Even though we are just a small Club we do a lot to promote the breed and put on several enjoyable events for both our show and pet members. Each year we tweak the events to better improve what we offer. Feedback is always welcome but it would be nice to have some positive feedback for a change. Sadly, there is a small number of show members who continue to complain about the Club.

Like everyone these days the committee are time poor and do their best to keep everyone informed on what is happening, put on worthwhile events that are spread out so roughly something every month to do with your Samoyed and uphold the rules so everyone is treated fairly. We had a really good entry for the Breed Shows last year and hopefully will again this year with two judges that have not judged our breed in NZ. With all the new puppies out and one's due out it will be nice to have some baby puppies. Lavinia MacKenzie-Goodwin, Marton is our open show judge and Shelley Turner, Victoria, Australia is our championship show judge. We have some lovely prizes lined up and will hopefully have our normal sponsors who are very generous. If anyone wants to help as photographer for the day please let me know. For next year we are trying to get a Samoyed Specialist and may need to move our show date to accommodate. Just a reminder any of the show members are welcome to suggest judges.

Despite always making a loss on the championship show we are managing mainly through fundraising to grow the finances so at last we have some money behind us as a Club. We continue to operate the SamCare account separate to the main Club account and donations to help with Samoyeds needing rescue are always gratefully received. Special thanks must go to Madaline Alexander for her recent donations to help with raising funds for SamCare. Very much appreciated. We have also had some books and pins donated from Zaminka and Samivahn that will be auctioned on Facebook. Thank you, John and Lyn.

We currently have a waiting list of people wanting older Samoyeds and are getting lots of enquires for puppies which are in short supply with several breeders having trouble getting bitches to conceive and whelp healthy puppies. As a Club we encourage breeders and "to be" owners to do the right thing in breeding with only health checked stock and buying from only NZKC registered breeders who health check. The Australian Clubs are working towards having a Litter Registration Limitation so maybe it is time to start thinking and talking about a Samoyed LRL in New Zealand.

I hope everyone enjoyed the 2019 Annual and this year we will again have a lot of events (with photos!) to look back on and populate the Annual for 2020.

1 STATEMENT OF ACCOUNTING POLICIES

The financial statements presented here are for The Samoyed Club Incorporated. The Samoyed Club Incorporated is an entity engaged in the business of a Club. The financial statements are prepared in accordance with the reporting requirements of Section 11 of the Financial Reporting Act 1993.

Measurement System

The measurement system adopted is that of historical cost.

Particular Accounting Policies

The following is a summary of the significant accounting policies adopted by the organization in the preparation of these financial statements.

Prepayments

Prepayments are stated at their estimated realizable value.

Fixed Assets & Depreciation

Fixed Assets are included at cost less aggregate depreciation. Depreciation of fixed assets is calculated on a diminishing value basis so as to allocate the cost of the assets over their useful lives. The rates of depreciation are shown in the Fixed Assets Schedule forming part of these financial statements.

Changes in Accounting Policies

There have been no changes in accounting policies. All policies have been applied on bases consistent with those used in previous years.

AUDIT REPORT

TO THE MEMBERS OF THE SAMOYED CLUB INDOPORATED

I have audited the financial statements on pages 1 to 6. The financial statements provide information about the past financial performance of the Samoyed Club Incorporated and its financial position as at 31/12/2019. The information is in accordance with the accounting policies set out on page 6.

Committee's Responsibility

The Committee is responsible for the preparation of the financial statements which fairly reflect the financial position of the Club as at 31/12/19 and the results of its operation for the year ended on that date.

Auditors' Responsibility

It is my responsibility to express an independent opinion on the financial statements presented by the Committee.

Basis of Opinion

An audit includes examining evidence, on a test basis, relevant to the amounts and disclosure in the financial statements. It also includes assessing the significant estimates and judgements made in the preparation of the statements, and whether the accounting policies are appropriate to the Club's circumstances, consistently applied and adequately disclosed.

I conducted my audit in accordance with New Zealand auditing standards. I have obtained all the information and explanations which I consider necessary to provide me with sufficient evidence to obtain reasonable assurance that the financial statements are free from material misstatements, whether caused by fraud or error. In forming my opinion I also evaluated the overall adequacy of the presentation of the information in the financial statements.

Other than in my capacity as auditor I have no relationship with or interest in the Club.

Qualified Opinion

In common with other organisations of a similar nature, control over income prior to being recorded is limited and there are no practical audit procedures to determine the effect of tis limited control.

However, subject to the above, it is my opinion that the financial statements fairly reflect the financial position of the Club and the results for the year ended 31/12/2019.

My audit was completed on 2 February 2020 and the qualified opinion is expressed at that date.
